CURRICULAR ASPECTS

1.1 - Curriculum Design and Development

1.1.1 - Curricula developed and implemented have relevance to the local, national, regional and global developmental needs which are reflected in Programme Outcomes (POs), Programme Specific Outcomes (PSOs) and Course Outcomes (COs) of the various Programmes offered by the Institution.

The college constantly strives to fulfil its institutional vision that of providing opportunities to students to pursue education which will culminate into a mind that researches and aims to achieve excellence. The College offers a wide variety of Under Graduate, Certificate courses and is also a Research centre for Ph.D. Programs. The pool of self-financing programs like PG programs in English, Marathi, Philosophy, History, Psychology (Industrial Psychology) & Sociology, BBI, BMM, BFM, BMS BIM & BAF has been introduced to cater the specific demands of the industry. The college introduces new curriculum after every three years. college takes up regular revision of courses every year. college on the basis of feedback of industry experts, students, alumni and faculty members assesses the existing curriculum and remove/delete /or add/include and update the components of curriculum from time to time. Every course designed upholds the values, interests, cultures of the society. The college involves industry, research bodies, subject experts, students, alumni and society in curriculum design and development to ensure relevancy and industry readiness of its programmes. The courses focus on national integration, cultural heritage, gender, environmental and other social issues. With the subject comibation of 520 courses, college offerd in BA program with specialisiation in 11 subjects at UG level, 6 MA programme at PG level and Advanced Accountancy in Mcom, along with regular BA, Bcom and other undergraduate programmes. Our college is also offering certification in Kautilya Arthshastra which train students in administration. The college has also introduced foreign language (Japanses & french) certificatr courses in order to develop linguistic skill to cater global need. In order to tackle stress issues of learners during pandemic, college has also introduced certificate course on Meditation. This course helps in improving mental health, increases concentration power & improves decision making skill among students. courses provide a professional edge to the students enhancing their employability. Value Education course sensitizes the students to various social issues and encourages them to deliberate and suggest ways to tackle them. Environmental Studies highlights the importance of environmentalconservation and sustainable development, a need urgently felt from the local to the international level. Personality Development and extension activities such as NCC, NSS, DLLE Students Service for the Differently Abled, Cultural Forum & EDC etc. grooms the students into responsible citizens for employment and life outside the institution. The postgraduate

programmes are enriched with intense curriculum and rigorous training for advanced research.

International Needs -The Language courses impart communication skills in global languages such as English, Spanish, German , Japanese and French. Computer Applications in Bcom programme and soft skills training equips the students with employability skills required at the international level. Courses on Social health, Political Economy of Globalisation, Introduction to econometrics, Research methodology in social science etc. which have value at the international level for both higher education and employability are offered to the students at the undergraduate and postgraduate levels. Similarly Accountancy & commerce course focuses on equipping students to accept the challenges of globalisation in the fields of accounting, management, business, marketing and HR. Similarly course on Philosophy acquaint students with the different religious and secular approaches to the environment. Our college provides academic flexibility wherein studetns can also opt for courses like Athletics, Football, Badminton, Sqaush & taekwondo as a part of curriculum. Our campus is having well equipped sports infrastruture & trainers so we can train our students to represent our country at national & international level.

National Needs Courses such as Enivornemtnal studies, Ancient Indian Sciences in Sanskrit, Sports, Indian Economic Thought, Foundation course etc., promote national integration and address issues of concern at the national level. Extension activities such as NCC, NSS, etc., promote national consciousness and prepare the students to be responsible citizens. PG & UG courses lay foundation for students to build careers in administration, law, academia, media, corporate world and Defense services that subsequently contribute to the development and progress of the country. A sound foundation in the Lifespan Development course in Psychology will prepare Psychology professionals to deal with issues of larger population. Similarly a course on Accountancy can help to build up entrepreneurship , management, marketing, organisational and human practices skills and pursue careers in the said domains. This course can help to pursue professional course like Chartered Accountant which is the most sought after career in India. Hindi and Sanskrit courses provide the necessary language skills and promote national culture. Also the program of journalism helps students to develop many communication skills through reporting, interviews, proof reading, editing, etc.

Regional Needs - BA English course fills in the gap of training students of vernacular media in English proficiency, which eventually leads to multi-fold job opportunities. Gujarati & Marathi courses also address regional needs. With the implementation of translation course, it enhance the skill of translation and also learn about different regional languages. Courses in History, Political Science, Economics and other disciplines highlights the regional issues & policies on the same.

Local Needs: The financial capital, Mumbai, with numerous multilevel organisations, requires workforce with expertise in English & Finance & accountancy, which undergraduates in English, Economics & commerce fulfill. Similarly other languages like Marathi, Hindi & Gujrati which has the addition of Lok-Sahitya (Folk Literature) and different linguistic Dialect, students can understand their responsibility as citizen to save folk heritage and culture. Similarly course on Philosophy helps to identify ethical issues that arise in contemporary society in the area of health, medical technology and sexuality. NSS, NCC & associations provides the students an opportunity for service learning and involve in extension activities. The extension activities help the local community through various awareness camps and programmes. Gujrati & Marathi are offered as courses in curriculum which promotes local language and culture. Marathi is also essential for employment in Maharshtra state government.

1.3 - Curriculum Enrichment

1.3.1 - Institution integrates cross-cutting issues relevant to Professional Ethics, Gender, Human

Values, Environment and Sustainability, and Human Values into the curriculum

The curricula include courses that integrate cross cutting issues relevant to gender, environment and sustainability, human values and professional ethics.

Professional Ethics: Courses such as Languages, Soft Skills, and certificate course on Kautilya Arthshastra inculcate leadership, communication, time management and other professional qualities in the students. A number of courses are offered which also impart domain specific professional ethics such as Industrial Psychology, Journalism, creative writing etc. To exemplify, Certificate courses on Varta Lekhan & How to read a film help in developing professionalism among students who wish to pursue career in Mass Sports as a part of curricular activtiy helps in building a Internships and project works are integral part of the curricula which foster professional ethics among the students. The language courses not only plays a pivotal role in enhancing linguistic competence but also is instrumental in inculcating core universal values like truthfulness, kindness, honesty, law, justice, patriotism, humanism etc. Students are sensitized about gender issues by its integration into the curricula.

Gender: As part of the Value Education course & curriculum of UG & PG course teaches the students concepts related to gender equality and discusses women's issues through texts and case studies. Women Development Cell, DLLE, NSS through their various activities like guest lectures, talk on health & hyigene, Laws to protect women rights helps in gender sensitization not only among female but also among male students. Gender budgeting as a part of our government policy is also discussed among students as a regular curriculum activity. Environment & Sustainability: Environmental Studies course is offered to all the undergraduate students highlighting the major environmental issues faced by us and emphasizing the importance of sustainable development. Courses such as Growth & development in Economics, Sociology, Languages integrate environmental issues from an interdisciplinary perspective. TYBA syllabus of Sanskrit course is revised to creat awareness about environment and the effect of Pandemic on environment for e.g. Bhumi sukta as a topic in syllabus. Field visit conducted by self financing courses, Sociology, Economics & EVS helps in giving practical experience on enviornmental degradation & helps them to realise importance of sustainable development. Green audit is also conducted every year wherein students volunteers assist in data collection. Such activity gives them hands on training on data collection related to enviornment & realise importance of gree audit & green technology.

Human Values: Value Education offered as a mandatory course to all the undergraduates stresses on human values, ethics and societal issues. The curricula offers a wide variety of courses with emphasis on human values such as Human Rights, Philosophy of Human Rights, Media Ethics and Human Rights, Sensitization to Social Issues, Community Sensitization, Social service for Differently Abled. Extension activities conducted by NSS, NCC & DLLE helps in emphasising the importance of social work. Team work helps to imbibe human values like kindness, patriotism, love for nature etc. Along with regular program, certificate course on Meditation helps in self realisation & appreciating importance of Yoga for happy & healthy human life.

Year 2020-21 was the year affected by the pandemic and lockdown. During this lockdown too lockdown all the departments took efforts to enhance online teaching learning experience. Somaiya College of Arts & Commerce (Autonomous). In the B.Com, learners are taught core subjects related to Commerce and Business Studies, Accounting, Auditing, Taxation and Business Economics. Besides, learners are given the option to choose from a few elective subjects to have cross-over learning.

Com is the best option and ideal for learners for pursuing a career in Commerce and Management, Accounting & Finance, Banking & Insurance etc. This Bachelor of Commerce degree is a foundation to P.G. Degree and Master's Programme, wherein the salary received by the candidate is generally the best in the industry.

Bachelor of Arts | B.A.

Our college has been offering the traditional three years Bachelor of Arts programme (B.A) from the time of its inception. This programme has been a popular, traditional choice for many students as it offered a variety of social science subjects (viz Psychology,

Philosophy, Political Science, Sociology and History) and languages (viz. English, Hindi, Marathi, Gujarati and Sanskrit) for study.

In its contemporariness, the B.A course in K J Somaiya College of Arts and Commerce in its Autonomous Status, has been fulfilling the basic requirements of employment industries like Print and Audio-Visual Media, Creative Arts, Performing Arts, Social Media, Management in Corporate and Banking Sectors, Mental Health Professionals, Library Sciences, Academia, Research and Higher Education, Public Service in State and Central Governments, Free-lancing in Journalism and in Entrepreneurship. Over the years, it has emerged as a very informed choice for students for its flexibility in choice of subjects and the combination of subjects offered at the Final year for specialization. With diversity in students admitted, subjects and languages offered, methodologies and pedagogies of teaching-learning, the six semesters of B.A course is a widely- accepted course, fulfilling unique need of every student.

Course Outcome

1. English

It is an Under-graduate, full time three-year course designed to develop intellectual and professional abilities of learners, in the realm of English and it's Literature. The objective of this course is to prepare students to use English proficiently, think critically and identify career paths in domains related to English and Literature in English. This program of six semesters is designed to introduce learners to various aspects and genres of English Literature. The teaching-learning process is within a pedagogical framework that is interesting and need-based.

1. Gujarati

It is an undergraduate full time 3-year course designed to develop

their intellectual, personnel and professional abilities. The objective of this course is to prepare students to think critically and find new ways to improve in the world of Gujarati literature.

This course is spread over 6 semesters. Each semester under this course makes sure that you are progressing step by step to meet the opportunities offered and face the challenges of the dynamic field of literature.

3. Economics

The Department of Economics was instituted in 1960. The department offers B.A. and B.COM, a three year duration semester based course. It has made a qualitative contribution in research activities and education in the field of economics since its initiation. Presently, Mrs. Jayshree Kotak is the Head of the Department, specializing in International Economics, Money Banking and Industry.

Departmental strength also consists of six assistant professors, among them four are the Doctor of Philosophy (Ph.D.) specialized in various areas of economics. Our department strives to reach a standard of excellence in teaching and research activities. Teaching faculties of the department allocate projects and guide on different economic related issues. Department offers six papers in TYBA including Econometrics and Mathematics which make the course more practical and skill oriented. Our department has a special cabin which helps students in group learning.

- B.A.- Degree in Economics (Three year- Semester system)
- B.Com. Degree (Three year- Semester system)

4.Hindi

Bachelor Of Arts Programme in Hindi is an UG-Programme of three years, which comprises 6 semesters. It includes the History of Hindi Literature, Linguistics, Grammar, Media Studies and Post-Modern Discourses. Functional Hindi and writing Skills are also incorporated. The syllabi is designed to help students inculcate values and passion for Hindi Literature.

5.Marathi

B.A. in Marathi is an undergraduate program in Marathi Language and Literature with focus on Linguistic and Literary skills. It aims to provide students with a broad knowledge of the field of Marathi, including understanding and realizing importance of Marathi Language in day to day life, in our social environment as well as in terms of career avenues.

Additional important language skills include translation and creative writing. The program also emphasizes the ability to write well, to do solid and innovative assignments in a specialized field or fields, to learn effectively, and to make articulate presentations in the classroom and beyond.

6.Philosophy

The Bachelor of Arts in Philosophy is a three year course. The papers that are offered in Philosophy are one paper in FYBA, two papers in SYBA and three papers at TYBA. The entire course of three years offers to enhance the student's ability to think critically, analytically and rationally about philosophical issues.

B.A Philosophy also teaches the students how to look at a particular thing from different perspectives which instigate the development of a liberal mindset. After having obtained the bachelor's degree in Philosophy, the students realize an important thing - no viewpoint has an ultimate basis and is subject to the socio-political background.

7.Psychology

The Bachelor of Arts (BA) with Psychology is a 120 credits 3-years course. Students are made well versed with various subfields of Psychology. In a span of three years, with six semesters, emphasis is on preparing sound foundation of the course, develop research aptitude and equip them with necessary knowledge and skills to pursue Psychology in the future.

8.Political Science

This is an undergraduate full time 3 year degree course designed to develop pupil's intellectual, rational up to the mark professional abilities. The intent of this course is to train students to think critically and creatively to find new ways to address and improve developmental and policy concerns and contribute to Political Science as an important discipline of Social Sciences.

This course is spread over 6 semesters. Each successive semester attempts to ensure that you are progressing step by step to meet the opportunities offered in and face the challenges of the dynamic/vibrant and rapidly changing world and the field of Political Science.

9.Sanskrit

A Bachelor of Arts program in Sanskrit entails the intensive study of Vedic, classical, and Modern Sanskrit Literature. Besides, introduction to various branches of knowledge (Shastra-s) in Indian Knowledge Tradition is also incorporated in this Programme. The programme involves practical aspects of language application through modern Sanskrit theatre.

This course is spread over 6 semesters. Each semester under this course makes sure that students internalize the ability to decode Sanskrit language and various Shastra-s to meet present needs.

10.Sociology

The Department of Sociology was established in the year 1972 and was consolidated by the efforts of eminent teaching faculties over the years. The prime motto of the department is 'Nurturing Social Responsibility' among students and thereby contributing to a critically aware citizenry. Teaching is learner-centric with appropriate and effective pedagogy being used to suit the needs and interests of students.

11.History

Bachelor of Arts (History) Programme is a three-year, full-time programme spread across six semesters. It aims to familiarize the students with regional, national and international history. The focus of the programme is on the history of personalities, events and

ideas that defined the past and paved the way for the making of the present. It aims to develop amongst the learners' varied interests in historical events and processes. It attempts to introduce the students to multiple perspectives which can be embraced to understand historical ideas and events. It also provides training in historical methodology along with an exposure to allied disciplines like Archaeology, Cultural Studies and Tourism.

Master of Commerce | M.Com.

A Master's of Commerce in Advanced Accountancy, abbreviated as M.Com degree is a two years spread over four semesters post graduate master's degree imparted in regular mode at K. J. Somaiya College of Arts & Commerce (Autonomous). In, M.Com - Advanced Accountancy, focus is on corporate accounting, taxation and strategic finance.

However, to solve the needs of managerial cadres in business and industry, a course on strategic management and research methodology is taught to the learners. Master in Commerce (M.Com) in itself a specialised post graduate degree programme to prepare an individual for a career in Accounting and Finance in the corporate sector as well as a basic qualification to enter into the teaching profession. M.Com, serves as an essential prerequisite for pursuing a Doctorate studies, Ph.D degree, focusing on Niche areas, emerging accounting fields.

Master of Arts | M.A.

1. History

M.A. The History Programme aims to develop an understanding of events, personalities, ideologies, and trends in history and train the students in historical research. It is a two-year full-time programme spread over four semesters. The programme opens the world of regional, national, and international history. A student completing M.A. can take up M.Phil. and Ph.D.

2.Philosophy | M.A. Philosophy

MA Philosophy is a 2-year postgraduate programme divided over the

four semesters. It is a majorly theoretical programme which imparts to students the knowledge of different philosophies around the world. A deep and critical study, this helps students to analyze the world better. The programme curriculum ranges from Indian philosophers to the Greek philosophers and also encompasses the western philosophers.

Philosophy, being a rational inquiry, sharpens our thinking, enriches our understanding and expands our intellectual horizons. To acquaint students with such a philosophical understanding the department of Philosophy offers programs of teaching and research in philosophy at M.A. level.

3. Psychology | M.A. Psychology

The Master of Arts (MA) in Psychology is 100 credits 2- years course. In the first year, the course is 24 credits per semester. There are four theory courses and one practical/field work.

In the second year, semester III includes five course work (four credits each) and one practical (10 credits) with a total of 30 credits. Semester IV has one interdisciplinary course (six credits), one ability enhancement course (six credits) and one project (10 credits). There is a balance of theory and practical orientation.

4. Marathi | M.A. Marathi

Spread across two years and four semesters, MA in Marathi has commenced from the academic year 2019-2020. M.A. in Marathi is an integrated two-year postgraduate programme in Marathi Language and literature with focus on critical thinking and contextual analysis.

It aims to provide students with a broad knowledge of the field of Marathi, including understanding and realizing the importance of Marathi Language in day-to-day life, in our social environment as well as in terms of career avenues. Additional important language skills include translation and creative writing. The programme also emphasizes the ability to write well, to do solid and innovative assignments in a specialized field or fields, to learn effectively, and to make articulate presentations in the classroom and beyond.

5. Sociology | M.A. Sociology

The Master of Arts (M.A.) in Sociology is a 100 credits two-years full-time course. In the first year, the core course is 24 credits per semester. In the second year, semester III includes five elective courses and one project with a total of 30 credits.

Semester IV has one interdisciplinary course, one ability enhancement course and one project. The project-based course will be in the form of a dissertation based on a live project or a research assignment related to the discipline. The programme incorporates theoretical knowledge as well as field work components.

6. English | M.A. English

Master of Arts in English, a post-graduate degree program is of two years and divided over the four semesters. The focus of this program is to provide comprehensive knowledge and train the learner to research. Thus, this level of degree is necessary to begin work towards earning a Master in Philosophy (M. Phil.) and ultimately Doctor in Philosophy (Ph. D.).

RESEARCH POLICY DOCUMENT

1. INTRODUCTION

Research is a prime area of the academic development and without research the knowledge will remain stagnant. The students and researcher scholars are required to have ethical and moral values in

academic pursuits in order to produce a genuine research work. In the present ICT era, information is easily available online and can be used as source material. In this context, plagiarism has become a serious problem. As per the Rules to consider the Proposals for Award of M.Phil./ Ph.D. Degree In Consonance with University Grants Commission Regulations, 2016 (Minimum Standard and Procedure for Award of M.Phil./Ph.D Degree) notified vide its Notification dated 5th May, 2016 and the UGC Notification on University Grants Commission (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018 will remain statutory rules, the Plagiarism Policy of K J Somaiya College of Arts and Commerce, Mumbai (Autonomous) has been formulated with a view to ensure that the institute ensures zero-tolerance for plagiarism in the research work either carried by the faculty, researchers or students.

The UGC has issued guidelines on the above subject vide its gazette notification, of 23rd July 2018, to ensure that the academic and research work done, leading to the partial fulfilment for the award of degrees at Undergraduate, Masters and Research level, by a student, faculty or a researcher, in the form of thesis, dissertation and publication of research papers, chapters in books, full-fledged books and/or any other similar work, showcases academic integrity and originality. 1. APPLICATION AND COMMENCEMENT

The policy shall apply to all students, faculty, researchers and staff of K J Somaiya College of Arts and Commerce, Vidyavihar (Autonomous), Mumbai. These regulations shall come into force with effect from the date of notification on the official College website.

1. OBJECTIVES

This research policy provides a broad framework to guide scholarly research with the following objectives:

 To create and promote a culture of research among the faculty and staff of K J Somaiya College of Arts and Commerce, Vidyavihar (Autonomous) Mumbai.

- 2. To identify research areas and specify research topics of academic, practical and socially relevant significance
- 3. To organize seminars/conferences/workshops on research topics and training programmes in research methodology.
- 4. To ensure quality, integrity and ethics in research.
- 5. To publish research material in appropriate media and to make available such published information to the end users.
- 6. To facilitate the publication of reports submitted by the research scholars
- 7. To bring about an annual/periodic compendium of abstracts/papers presented by the staff and students in various seminars / conferences / workshops.
- 8. To serve as a facilitator providing professional guidance, technical support and recommendation for financial assistance.
- 9. To protect Intellectual Property (IP) generated as a result of research conducted at KJSAC.
- 10. To integrate research activities undertaken and create a rational, transparent and efficient system for management of all research processes

1. PROMOTION OF RESEARCH

The K J Somaiya College of Arts and Commerce, Vidyavihar Mumbai believes that researchers are free to choose the subject of their research, to seek support from any funding source for their research work, and to report their findings and conclusions.

However, research shall be available for scrutiny to the college and constructive criticism of peers. Research techniques used by the researchers shall not violate established professional ethics, pertaining to the health, safety, privacy, and other personal rights of human beings or to the infliction of injury or pain on animals.

The College shall create conducive environment for research. Due to limited resources, the college may not support fully all research likely to be undertaken, but it shall allocate the space, facilities, partial funding, and other resources for research programmes based on the scholarly and educational merits of the proposed research. It shall also provide development opportunities to researchers for writing research proposals and reports, publications, patent filing, etc.

1. RESEARCH AT UNDERGRADUATE AND POSTGRADUATE LEVEL

K J Somaiya College of Arts and Commerce treats teaching and learning should always be amalgamated at each level. Thus, equal opportunities at the graduate and post-graduate level are given and help to promote creativity among the undergraduate and post-graduate students, some research component in the curricula, especially in the final or pre-final year of the bachelors programme and final year in the master's programme is implemented. Accordingly, in the final year of the bachelors programme the Minor Research Project and Major Research Project are inducted where the students under the guidance of the faculty work on the decided topic of the dissertation and submit the findings periodically. The final project is submitted to the institution and also the viva is conducted. Similarly, in the postgraduate programme, research was emphasised emphatically and students were trained for robust research skills. The college shall further reinforce research training in both undergraduate and postgraduate programmes in the future.

1. DOCTORAL RESEARCH

The steps towards the expansion of doctoral programmes are commenced both for full-time scholars and external scholars. Though, college is having limited finance and resources for conducting research and also in the development of the rich infrastructure for conducting research in different fields; therefore, it was decided to allow the research scholars and teachers to collaborate with different prominent National institutions where they have requisite research infrastructures and also have expertise to guide the scholars in different areas. The college shall further boost doctoral research and earmark appropriate budget for scholarship and research facilities in different institutions. It shall also recognise the worthy R&D organisations for doctoral research and build bridges with them. The college shall continue to encourage faculty and research scholars to get funding for attending International conferences from external agencies as a matching share so that the quality in research paper can be maintained. It shall urge research scholars to publish and patent/obtain copyrights their research work.

1. MINOR RESEARCH PROJECTS

From the very beginning, the college has encouraged young faculty to conduct research. Thus, it has developed a mechanism to guide and facilitate the financial assistance to Minor Research Project. Minor Research Project will be verified and periodical assessment of the

The committee will help young faculty think about research, prepare the proposal, conduct research and write a research report. It also assists them in preparing proposals for major research projects. The college shall continue to encourage young faculty to take up minor research projects.

The college will identify a list of funding agencies. Faculty can submit Major Research Project proposals to these agencies. These proposals are scrutinised before submitting the same to a funding agency by Research, Review and Recommendations Committee. The college will try to provide all kinds of infrastructure facilities available for conducting a Major Research Project. The college plans to evolve a mechanism through which it shall monitor the progress of Major Research Projects funded by an external agency, maintain its accounts and submit the utilising certificate in time to the funding agency as per the requirement of the funding agency.

1. COLLABORATIVE RESEARCH PROJECTS

The Academic-Industry Interaction is the demand of the day. If we want to contribute to the society at large, the college has to closely work with industries and different organisations. The college has planned to encourage industry Sponsored Research Project, Interdisciplinary Research, Collaborative International Research, Training for Research and Publications, Publication of Papers and Journals and helping the researchers in copyrights /Patent and IPR.

Institution has augmented adequate physical as well as technical amenities to facilitate a smooth teaching-learning process. The auditorium is self-reliant with its own full-fledged music system required for conducting programmes. It has 2 green rooms backstage required by performers and organisers for their arrangements before any performance. The Institution has also facilitated a RAM for the disabled so that they can smoothly make up to the stage.

The Institution also has a well-equipped gymnasium for indoor games and physical fitness, consisting of Table Tennis, Carrom, Chess facility, with Football and Cricket kits for outdoor games and Treadmills and Dumbells for workouts. Apart from the college gymnasium, students of the institution can have access to all the sports facilities offered by the Somaiya Vidyavihar management across the campus viz., football ground, basketball court, cricket ground, cricket nets, Kabbadi, Kho-kho ground, Tennis court, Athletic track, Badminton court, Outdoor chess, Squash court, Volleyball court, multi-purpose surface, Kalaripayattu, Taekwondo, Table Tennis court and Gymnasium.

4.2 - Library as a Learning Resource

4.2.1 - Library is automated using Integrated Library Management System (ILMS)

K. J. Somaiya College of Arts and Commerce Library is the oldest and biggest library in the Vidyavihar campus. The total area of it is 10732-sq. ft. comprising of 418 chairs with 80 tables for studying. College library projects a splendid collection of 87000+ books, 758 e-books, 124 periodicals, 2 e-resources, 825 back volumes, 427 rare collections, 8 braille collections, 18 Theses, 1684 CDs, 31 audio cassettes, 59 video tapes, 136 maps and 18 newspapers. The book collection covers most of the areas of knowledge. Though the emphasis is on Indian publications there is a good collection of foreign publications too.

The approximate yearly budget varies from Rs. 6,00,000 to Rs. 7,00,000 including periodicals and journals. Nearly 2000 to 2500 books are added every year. Yearly 50 periodicals are subscribed, out of which four are foreign publications. Many journals are bound after completion of the volume. Past question papers and syllabi are available for reference. Library helps to get photocopies of syllabi to the students going for further studies in foreign countries. Library also maintains a special collection on Career Guidance, Gandhian Literature, material for competitive examinations and CA studies, and a collection of Biographies. It also has some rare books, which are not available in the market and now beyond copyright laws.

There are 4 counters in the library for current reading, home issue, staff issue and reference counter. Library is divided into 8 sections, viz., Acquisition, Periodical, Reference, Current Reading, Home issue, Staff and PG issue, Internet and Computers section and Book-bank. Library is offering free internet, photocopy and print facility to staff and students.

The Institution has a fully automated and user-friendly Library for

the benefit of staff and students. The Somaiya Trust has proposed an in-House software programme 'BOOK WARM', which will help to link all libraries in the campus. It has a complete catalogue on computers and Bar-coding has been done. Besides this circulation and statistical records are also maintained on computers. The program has provision for making and printing lists of books for various purposes.

Students can renew books themselves through online (KIOSK), provided the book is not

in demand/reserved. Students can reserve the books through Web OPAC which are not available in the library (issued to other members). System will notify the students through email, to return the book on or before the due date and once the reserved book is back into the library, the system will send notification through an email to the students who reserve the book.

4.4.2 - There are established systems and procedures for maintaining and utilizing physical, academic and support facilities – classrooms, laboratory, library, sports complex, computers, etc.

Institution has a built-in mechanism well communicated through policy manuals for maintaining and utilizing physical, academic, support facilities, viz., for computer lab, library, sports, etc.

Library - Staff and students can login into My Account on Somaiya Vidyavihar Home Page on Library portal through the integrated ID SVV Net ID and Password which is already sent on their mobile and also on their email. Students can renew books themselves online, provided the book is not in demand/reserved before the due date. Undergraduate students can renew the book only once while postgraduate students can renew it twice. Any Member can borrow any one book for seven days from any library of Somaiya Campus. At the Current Reading Counter the textbooks, general books, question papers are provided for current reading only, against the Identity Card. It is necessary to take the Librarian's permission for borrowing books overnight. If the book is not returned in time the student is fined Rs. 2/- per day. Books and periodicals are issued to staff members of the college. Generally books, other than textbooks, are issued for one month and periodicals for seven days. The staff members can borrow not more than 20 books and not more than 2 periodicals at a time. P. G. students are issued two books at a time for home lending for 7 days and three books at a time to read within the library. Reference books marked "R" before class number and Rare Old books are not issued for home reading. All Newspapers are made available for Students & Staff members in the Reference Section. Silence must be maintained in the reading room and any kind of discussion is not permitted in the reading area. Students are not allowed to eat in the library. Guidelines for the use of the Library are informed to staff and students.

Sports - Sports facilities in the institution as well as across the campus are available for use to staff and students provided they

produce their appropriate Somaiya ID Cards / Sports Facilities User Cards issued by the Somaiya Sports Academy. Written guidelines regarding rules and regulations to use sports facilities are available and duly informed. Necessary online bookings are essential to use Somaiya sports facilities. Access to all the sports facilities is free of cost for all current students. The student/ player must be in appropriate sports attire i.e. sports specific shoes, t-shirt, Shorts/ track pants. Users will be responsible for any damage to the property in the sports facilities, such as lockers, windows, flooring, furniture, etc. Photo taking with/without flash and video filming are NOT allowed inside the sports facilities, except if an exclusive permission is taken from the Security and Sports academy. Food, beverages, pets are strictly not permitted into the sports facilities. Smoking and gambling of any sort is strictly prohibited in and around sports facilities.

Laboratory - Computer and Language lab can be used by staff and students subject to furnishing of Somaiya ID card. Lab facilities can be used only in the presence of Lab-in-charge or Lab assistant.

Research Centre - Institute ensures zero-tolerance for plagiarism in the research work either carried by the faculty, researchers or students. The policy shall apply to all students, faculty, researchers and staff of the institute. The research policy provides broad framework to guide scholarly research with the objectives like create and promote research culture, identify academically, practically and socially relevant research areas, organise programmes in research methodology, facilitate publication of research material, provide professional guidance, technical support, recommendation for financial assistance, ensure quality, integrity and ethics in research, protect Intellectual Property Right of research conducted by researchers.

Principal Level: The Governing Body delegates all the academic and operational decisions based on policy to the Academic Monitoring Committee headed by the Principal in order to fulfill the vision and mission of the institute. Committee formulates common working procedures and entrusts the implementation with the faculty members.

Faculty Level:

Faculty members are given representation in various committees/cells and allowed to conduct various programs to showcase their abilities and encouraged to develop leadership skills by being in charge of various academic, co-curricular, and extracurricular activities. Principal is entrusted to implement academic and administrative system and monitor examination committee/College Examination Officer, internal and external Examination activities, examination planning, CAP, Results etc. Faculty members either in the capacity of the chairperson or the committee members represent the NSS unit of the college, Research committee, Training, placement and career counselling cell, Entrepreneurship Development Cell, Student welfare committee, Cultural and sports committee, Student grievances Redressal committee, Accountants, Library Committee, Ant-ragging committee and several other committees.

Student Level:

Students are empowered to play an active role as a coordinator of Cocurricular and extracurricular activities, social service group coordinator.

Participative management:

The institute promotes a culture of participative management by involving the staff and students in various activities. Both students and faculties allowed giving suggestions resulting in the academic excellence.

Strategic Level:

The principal, academic co-coordinator and staff members are involved in defining the policies and procedures, framing guidelines and rules, regulations pertaining to admission, placement, discipline, grievance, counselling, training development, and library services etc., and effectively implementing the same to ensure smooth and systematic functioning of the institute.

Curriculum Development:

Curriculum development is taken care of by individual departments as per specific requirements. Syllabus is reviewed and revised as per the suggestions and recommendations given by the expert members of the Subject Board. It is comprises of University Nominee, Subject Experts, Industry Expert, Faculties of Department and Alumni.

Teaching and Learning:

Teachers use Traditional as well as Modern methods to inculcate practical aspects of the subject and to make the students understand the different concepts. Teachers use Traditional Methods like Black Board, Group Discussions, Assignments and Projects, whereas modern methods include PPT Presentations, Google Classrooms, Smart boards, Role Plays, Management games, Visit to Industries etc. Remedial Classes are organized for students of first year, second year, third year Arts and Commerce students to help them prepare for the semester end examinations. Though the medium of instruction is English, teachers are requested to explain points in Marathi and or in Hindi to help vernacular medium students understand important concepts.

Examination and Evaluation:

The academic year 2016-17 saw a change in the examination pattern. The internal evaluation for all subjects is done according to the nature and scope of the subject as follows:

Internal Examination Pattern:

- 1 Management Related Subject -Management Games, Power point Presentations.
- 2 Accounts and costing -Written Examination or Project
- 3 Foundation Course -Project on Social Issues
- 4 Security Analysis Portfolio Management-Comparison of two companies of market on the basis of Technical and fundamental analysis
- 5 Mutual Fund Management Study of Fact Sheet on different mutual funds and Viva
- 6 Research Methodology Project on different topics and viva conducted by external industry experts.
- 7 Banking laws and corporate Laws, Role Play and Moot Court

Online Examination (Using Smart Phones or Android phones) is conducted through OFFEE Software developed by the alumni of the Somaiya college. 20 Marks are allotted to Internal Examination and 5 marks for attendance and overall conduct of the students.

Research:

Research has been considered as an important integral part of the academic endeavours in our college. Many Seminars and workshops are organized by the college to provide expert information on Research Methodology. The college promotes faculty participation in research by granting them leave, helping them in participation of Faculty Improvement programmes and arranging books required by them. All teachers are encouraged to participate and present research papers in International, National State Level Conferences. They are encouraged to take Major and Minor Research Projects. The Management of the Institute has a policy of felicitating the faculty members acquiring Ph.D. Degree at annual prize distribution ceremony. Students are continuously encouraged to undertake Research Projects related to their curriculum.

Library, ICT and Physical Infrastructure / Instrumentation:

The prime objective of Library as a learning resource is to acquire,

develop, maintain and provide a qualitative and quantitative collection of books, periodicals and other instructional material of electronic resources to support the academic program and educational goals of the college. All the modern ICT facilities are available in the college such as Language Lab and Research lab.

Human Resource Management:

The college has adopted mandatory Self-Appraisal Method to evaluate the performance of faculty in teaching, research and extension programmes. At the end of the academic year, every teacher is given an Academic Performance Indicator (API) form on the basis of UGC requirements. Teachers are required to give self-evaluation of academic, co-curricular and extracurricular work done during that academic year. The data of the papers presented at conferences, seminars, refreshers courses and orientation programmes attended is also maintained regularly.

Industry Interaction / Collaboration:

Experts are invited from various fields to deliver guest lectures and industrial visits are arranged. The career guidance and placement cell organize education visits to Reserve Bank of India, BSE/NSC Market, and SEBI. Career fares are frequently organized for placement of the students.

Every year we Celebrate the National festival of Patangotsav (Kite Festival) on 14th January. In which we create a Mini Gujarat in our college campus. Participants of festival also come to know the culture of food and flying kite. Also they enjoy the same. In this festival student of every language and department also takes part. Department of Marathi celebrated Maharashtra Day with 37 participants (including students and teachers) making one minute video each on the language and culture of Maharashtra, and jointly these videos were made viral through WhatsApp on various groups Department of Marathi celebrate Marathi Bhasha Sanwardhan Pandharwada by organizing 5 different competitions for students. Best practice: 1 1.

- 1. Title of the practice Gyan Yagna 2.
- 2. The context that required the initiation of the practice: Our founder Padma Bhushan Shri. Karamshi Jethabhai Somaiya, was pained to see the indifference of youth towards Sanskrit, sanskriti and samskara. Our scriptures are cradle of Indian culture and heritage, treasure of spirituality and great traditions. Young students should not only be made aware of our great scripture but also love and respect our Indian culture. With this motive, Padma Bhushan Shri. Karamshi Jethabhai Somaiya started Gyan Yagna Spiritual sessions in the Somaiya Vidyavihar campus in 1989 and since then we have been following the tradition by organsing these sessions every year in the month of January.
- 3. Objectives of the practice: The prime objective for organising Gyan yagna is to provide spiritual and Para medical services to the society. We involve students in organising these events whereby giving platform for students to do social work and also to learn event management. Cultural programmes are also organised to develop interest in different arts among students.
- 4. The Practice: Every year great Saints and Sages are invited to speak on Sanskrit texts Veda, Upanishads Purana and Bhagvadgita etc. The Founder of Manana Ashram, Param pujya Shri Tejomayanand, his disciple Swamini Tanmayananda, Swami Chinmayananda, Parama pujya Shri Haribhai Kothari, Swami Avadhutanada maharaj, and many more have been the prominent speakers. As the programme became more popular, gradually two hours in the evening were kept for Cultural programmes like Folk music, folk dance and drama. Further, we had introduced two sessions in the morning where second session was allocated for

health. In this session renowned Doctors were invited to speak on health issues and their solutions. Yoga practices were organised. In the year 2021, due to pandemic all events were organised virtually using Zoom platform. Every day Gyan Yagna started with 1st morning session of Pravachan for 7:00 to 8:00 a.m. After providing food for mental health programme was followed by Yoga / Speech / medical camp. In the evening between 6:30 to 8:30 cultural programs were organised.

- 5. Obstacles faced if any and strategies adopted to overcome them: In 2021, pandemic hindered the physical organisation of this event. Considering the viability of the situation, this event was organised online. Although our college is well equipped with IT team, we could not help the attendees to resolve technical issues faced at their end. Every year this programme was organised from morning to evening for one month. But this year it was not feasible to have this program for the whole day so we had it in different slots every day. Most of the speakers were not technology savvy so we faced problem in the conduct of their sessions. As this program is open for all, we generally face issue of security.
- 6. Impact of the practice: In COVID pandemic, when we are surrounded by negative news everywhere, which increased our worries for the social and economic wellbeing of our society, there was a need to spread positivity to overcome all the fear. This event Gyanyagya has been able to create positivity amongst the participants. There arises a need to uplift the physical and mental health of everyone. Gyanyagya through its daily sessions, made an attempt to connect the participants with Indian culture.
- 7. Resources required: There are extensive resources like infrastructure, staff and student volunteers, required to pull out this event on a huge scale for a duration of one month. Management has always been keen to support this event in every possible way. In last 32 years, Gyanyagya have never stopped for the dearth of resources.

Best practice: 2

- 1. Title of the Practice: Drushti Film Forum
- 2. The context that required the initiation of the practice :

Established in 2007, Drushti Film Forum is a Film Society of the Somaiya Vidyavihar campus, initiated by K.J. Somaiya College of Arts and Commerce. Revised in 2013, so far, it has screened more than 250 films across the countries and themes. (A Film Society is a membership club where people can watch films which would otherwise not be shown in mainstream cinemas.) Drushti Film Forum was established in the academic year 2007-2008 and was inaugurated on 8th August 2007, at the hands of senior actress Suhasinee Muley.

- 3. Objectives of the practice: Drushti Film Forum, with regular weekly Screenings of World Cinema, serves as an effective tool to introduce the Art and Aesthetics of cinema to students. It aims to develop a larger world view in them as this art form introduces them to the realities in the world as well as the advance techniques of medium.
- 4. The Practice: Film is a modern Art form and can be effectively used to educate young minds. In western and European countries, Film is a part of regular curriculum in schools whereas at college and University levels, they have Film Studies departments for much specialized courses in Cinema. For Drushti Film Forum, Film is not merely an entertaining medium but a window to the world. Hence, we preferably screen films from all over the world, from different genres and unconventional subject content. It's their exposure to the World Cinema. Drushti Film Forum used to screen and discuss World Cinema in the college auditorium regularly on weekly basis except examinations and vacation period. Due to pandemic situation, we, for a time being, moved on to online screenings. YouTube link of movies is shared with students on every Friday and they are asked watch it by Sunday, while the film is discussed on every Monday. Along with screenings, we initiate academic discussions on cinema, provide them reference material, conduct film appreciation workshops, encourage them to be part of International Film Festivals.
- 5. Obstacles faced if any and strategies adopted to overcome them: Despite our sincere efforts, hardly 100 students regularly attend the screening. And very few students attend the online discussion. However the number of students participating is increasing every year, and efforts are being made to screen movies on topics that interest students.
- 6. Impact of the practice: So far, our four students, Raunak Raje (2010-11), Karan Jhala(2013-2014), Salim Shaikh (2014-2015), Saba Purkar (2015-2016), Omkar Kulkarni and Payal shah (2016-17) have been selected as Young Critics at MAMI International Film Festival

in Mumbai.

- 1 Gyan Yagna is a thirty two year old practice that takes place in Somaiya campus. Gyan Yagna takes place for 30 days every year. It begins on the first day of the year and lasts till end of month of January. It has threefold goal spiritual, paramedical and cultural. In modern busy life, while running behind material goals, we have no time to give for ourself. This race with time starts since early

studenthood. This leads to several problems at an early age. These problems are of physical as well as psychological nature. The practice of 'Gyan Yagna' addresses all such problems through various spiritual, paramedical and cultural activities with the aim of enriching overall experience of participants, ultimately aiming to lead them to self-realization. The K. J. Somaiya trust and Somaiya Sanskritivihar provide full financial support for the event. 2 The Drishti Film Forum of the college organises screening of movies from world cinema to inculcate interest in film appreciation among students to develop good viewers for films. It conducts film review competitions and film festivals in collaboration with the other departments of the college to study the film from a various perspectives. 3 Entrepreneurship Development Cell is functioning in the campus and the cell encourages the students to start start-ups. 4 The Center for Gandhian studies was established in 2006 under the scheme of Epoch Making Social Thinkers. The Centre organizes seminars, competitions & field visits and has a well-equipped library. 5 We start every function in our college with our campus prayer. 6 Scholars' Card is given to meritorious students in Library. To inculcate the habit of using library among students Library Best Book Reader Prize is given annually.

CURRICULAR ASPECTS

1.1 - Curriculum Design and Development

1.1.1 - Curricula developed and implemented have relevance to the local, national, regional and global developmental needs which are reflected in Programme Outcomes (POs), Programme Specific Outcomes (PSOs) and Course Outcomes (COs) of the various Programmes offered by the Institution.

The college constantly strives to fulfil its institutional vision - that of providing opportunities to students to pursue education which will culminate into a mind that researches and aims to achieve excellence. The College offers a wide variety of Under Graduate, Certificate courses and is also a Research centre for Ph.D. Programs. The pool of self-financing programs like PG programs in English, Marathi, Philosophy, History, Psychology (Industrial Psychology) & Sociology, BBI, BMM, BFM, BMS BIM & BAF has been introduced to cater the specific demands of the industry. The college introduces new curriculum after every three years. The college takes up regular revision of courses every The college on the basis of feedback of industry experts, students, alumni and faculty members assesses the existing curriculum and remove/delete /or add/include and update the components of curriculum from time to time. Every course designed upholds the values, interests, cultures of the society. The college involves industry, research bodies, subject experts, students, alumni and society in curriculum design and development to ensure relevancy and industry readiness of its programmes. The courses focus on national integration, cultural heritage, gender, environmental and other social issues. With the subject comibation of 520 courses, college offerd in BA program with specialisiation in 11 subjects at UG level, 6 MA programme at PG level and Advanced Accountancy in Mcom, along with regular BA, Bcom and other undergraduate programmes. Our college is also offering certification in Kautilya Arthshastra which train students in administration. The college has also introduced foreign language (Japanses & french) certificatr courses in order to develop linguistic skill to cater global need. In order to tackle stress issues of learners during pandemic, college has also introduced certificate course on Meditation. This course helps in improving mental health, increases concentration power & improves decision making skill among students. These courses provide a professional edge to the students enhancing their employability. Value Education course sensitizes the students to various social issues and encourages them to deliberate and

suggest ways to tackle them. Environmental Studies highlights the importance of environmentalconservation and sustainable development, a need urgently felt from the local to the international level. Personality Development and extension activities such as NCC, NSS,DLLE Students Service for the Differently Abled, Cultural Forum & EDC etc. grooms the students into responsible citizens for employment and life outside the institution. The postgraduate programmes are enriched with intense curriculum and rigorous training for advanced research.

International Needs -The Language courses impart communication skills in global languages such as English, Spanish, German , Japanese and French. Computer Applications in Bcom programme and soft skills training equips the students with employability skills required at the international level. Courses on Social health, Political Economy of Globalisation, Introduction to econometrics, Research methodology in social science etc. which have value at the international level for both higher education and employability are offered to the students at the undergraduate and postgraduate levels. Similarly Accountancy & commerce course focuses on equipping students to accept the challenges of globalisation in the fields of accounting, management, business, marketing and HR. Similarly course on Philosophy acquaint students with the different religious and secular approaches to the environment. Our college provides academic flexibility wherein studetns can also opt for courses like Athletics, Football, Badminton, Sqaush & taekwondo as a part of curriculum. Our campus is having well equipped sports infrastruture & trainers so we can train our students to represent our country at national & international level.

National Needs Courses such as Enivornemtnal studies, Ancient Indian Sciences in Sanskrit, Sports, Indian Economic Thought, Foundation course etc., promote national integration and address issues of concern at the national level. Extension activities such as NCC, NSS, etc., promote national consciousness and prepare the students to be responsible citizens. PG & UG courses lay foundation for students to build careers in administration, law, academia, media, corporate world and Defense services that subsequently contribute to the development and progress of the country. A sound foundation in the Lifespan Development course in Psychology will prepare Psychology professionals to deal with issues of larger population. Similarly a course on Accountancy can help to build up entrepreneurship, management, marketing,

organisational and human practices skills and pursue careers in the said domains. This course can help to pursue professional course like Chartered Accountant which is the most sought after career in India. Hindi and Sanskrit courses provide the necessary language skills and promote national culture. Also the program of journalism helps students to develop many communication skills through reporting, interviews, proof reading, editing, etc.

Regional Needs - BA English course fills in the gap of training students of vernacular media in English proficiency, which eventually leads to multi-fold job opportunities. Gujarati & Marathi courses also address regional needs. With the implementation of translation course, it enhance the skill of translation and also learn about different regional languages. Courses in History, Political Science, Economics and other disciplines highlights the regional issues & policies on the same.

Local Needs: The financial capital, Mumbai, with numerous multilevel organisations, requires workforce with expertise in English & Finance & accountancy, which undergraduates in English, Economics & commerce fulfill. Similarly other languages like Marathi, Hindi & Gujrati which has the addition of Lok-Sahitya (Folk Literature) and different linguistic Dialect, students can understand their responsibility as citizen to save folk heritage and culture. Similarly course on Philosophy helps to identify ethical issues that arise in contemporary society in the area of health, medical technology and sexuality. NSS, NCC & associations provides the students an opportunity for service learning and involve in extension activities. The extension activities help the local community through various awareness camps and programmes. Gujrati & Marathi are offered as courses in curriculum which promotes local language and culture. Marathi is also essential for employment in Maharshtra state government.

1.3 - Curriculum Enrichment

1.3.1 - Institution integrates cross-cutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability, and Human Values into the curriculum

The curricula include courses that integrate cross cutting issues relevant to gender, environment and sustainability, human values and professional ethics.

Professional Ethics: Courses such as Languages, Soft Skills, and certificate course on Kautilya Arthshastra inculcate leadership, communication, time management and other professional qualities in the students. A number of courses are offered which also impart domain specific professional ethics such as Industrial Psychology, Journalism, creative writing etc. To exemplify, Certificate courses on Varta Lekhan & How to read a film help in developing professionalism among students who wish to pursue career in Mass media. Sports as a part of curricular activtiy helps in building a Internships and project works are integral part of the curricula which foster professional ethics among the students. The language courses not only plays a pivotal role in enhancing linguistic competence but also is instrumental in inculcating core universal values like truthfulness, kindness, honesty, law, justice, patriotism, humanism etc. Students are sensitized about gender issues by its integration into the curricula.

Gender: As part of the Value Education course & curriculum of UG & PG course teaches the students concepts related to gender equality and discusses women's issues through texts and case studies. Women Development Cell, DLLE, NSS through their various activities like guest lectures, talk on health & hyigene, Laws to protect women rights helps in gender sensitization not only among female but also among male students. Gender budgeting as a part of our government policy is also discussed among students as a regular curriculum activity. Environment & Sustainability:

Environmental Studies course is offered to all the undergraduate students highlighting the major environmental issues faced by us and emphasizing the importance of sustainable development. Courses such as Growth & development in Economics, Sociology, Languages integrate environmental issues from an interdisciplinary perspective. TYBA syllabus of Sanskrit course is revised to creat awareness about environment and the effect of Pandemic on environment for e.g. Bhumi sukta as a topic in syllabus. Field visit conducted by self financing courses, Sociology, Economics & EVS helps in giving practical experience on enviornmental degradation & helps them to realise importance of sustainable development. Green audit is also conducted every year wherein students volunteers assist in data collection. Such activity gives them hands on training on data collection related to enviornment & realise importance of gree audit & green technology.

Human Values: Value Education offered as a mandatory course to all the undergraduates stresses on human values, ethics and societal issues. The curricula offers a wide variety of courses with emphasis on human values such as Human Rights, Philosophy of Human Rights, Media Ethics and Human Rights, Sensitization to Social Issues, Community Sensitization, Social service for Differently Abled. Extension activities conducted by NSS, NCC & DLLE helps in emphasising the importance of social work. Team work helps to imbibe human values like kindness, patriotism, love for nature etc. Along with regular program, certificate course on Meditation helps in self realisation & appreciating importance of Yoga for happy & healthy human life.

and languages (viz. English, Hindi, Marathi, Gujarati and
Sanskrit) for study.

In its contemporariness, the B.A course in K J Somaiya College of

Arts and Commerce in its Autonomous Status, has been fulfilling the basic requirements of employment industries like Print and Audio-Visual Media, Creative Arts, Performing Arts, Social Media, Management in Corporate and Banking Sectors, Mental Health Professionals, Library Sciences, Academia, Research and Higher Education, Public Service in State and Central Governments, Freelancing in Journalism and in Entrepreneurship. Over the years, it has emerged as a very informed choice for students for its flexibility in choice of subjects and the combination of subjects offered at the Final year for specialization. With diversity in students admitted, subjects and languages offered, methodologies and pedagogies of teaching-learning, the six semesters of B.A course is a widely- accepted course, fulfilling unique need of every student.

Course Outcome

1. English

5.Marathi

B.A. in Marathi is an undergraduate program in Marathi Language and Literature with focus on Linguistic and Literary skills. It aims to provide students with a broad knowledge of the field of Marathi, including understanding and realizing importance of Marathi Language in day to day life, in our social environment as well as in terms of career avenues.

Additional important language skills include translation and creative writing. The program also emphasizes the ability to write well, to do solid and innovative assignments in a specialized field or fields, to learn effectively, and to make articulate presentations in the classroom and beyond.

6.Philosophy

The Bachelor of Arts in Philosophy is a three year course. The papers that are offered in Philosophy are one paper in FYBA, two papers in SYBA and three papers at TYBA. The entire course of three years offers to enhance the student's ability to think critically, analytically and rationally about philosophical issues.

B.A Philosophy also teaches the students how to look at a particular thing from different perspectives which instigate the development of a liberal mindset. After having obtained the bachelor's degree in Philosophy, the students realize an important thing - no viewpoint has an ultimate basis and is subject to the socio-political background.

7.Psychology

The Bachelor of Arts (BA) with Psychology is a 120 credits 3-years course. Students are made well versed with various subfields of Psychology. In a span of three years, with six semesters, emphasis is on preparing sound foundation of the course, develop research aptitude and equip them with necessary knowledge and skills to pursue Psychology in the future.

8.Political Science

The intent of this course is to train students to think critically and creatively to find new ways to address and improve developmental and policy concerns and contribute to Political Science as an important discipline of Social Sciences.

This course is spread over 6 semesters. Each successive semester attempts to ensure that you are progressing step by step to meet the opportunities offered in and face the challenges of the dynamic/vibrant and rapidly changing world and the field of Political Science.

9.Sanskrit

A Bachelor of Arts program in Sanskrit entails the intensive study of Vedic, classical, and Modern Sanskrit Literature. Besides, introduction to various branches of knowledge (Shastras) in Indian Knowledge Tradition is also incorporated in this Programme. The programme involves practical aspects of language application through modern Sanskrit theatre.

This course is spread over 6 semesters. Each semester under this course makes sure that students internalize the ability to decode Sanskrit language and various Shastra-s to meet present needs.

10.Sociology

The Department of Sociology was established in the year 1972 and was consolidated by the efforts of eminent teaching faculties over the years. The prime motto of the department is 'Nurturing Social Responsibility' among students and thereby contributing to a critically aware citizenry. Teaching is learner-centric with appropriate and effective pedagogy being used to suit the needs and interests of students.

11.History

Bachelor of Arts (History) Programme is a three-year, full-time programme spread across six semesters. It aims to familiarize the students with regional, national and international history. The

focus of the programme is on the history of personalities, events and ideas that defined the past and paved the way for the making of the present. It aims to develop amongst the learners' varied interests in historical events and processes. It attempts to introduce the students to multiple perspectives which can be embraced to understand historical ideas and events. It also provides training in historical methodology along with an exposure to allied disciplines like Archaeology, Cultural Studies and Tourism.

Master of Commerce | M.Com.

A Master's of Commerce in Advanced Accountancy, abbreviated as M.Com degree is a two years spread over four semesters post graduate master's degree imparted in regular mode at K. J. Somaiya College of Arts & Commerce (Autonomous). In, M.Com - Advanced Accountancy, focus is on corporate accounting, taxation and strategic finance.

However, to solve the needs of managerial cadres in business and industry, a course on strategic management and research methodology is taught to the learners. Master in Commerce (M.Com) in itself a specialised post graduate degree programme to prepare an individual for a career in Accounting and Finance in the corporate sector as well as a basic qualification to enter into the teaching profession. M.Com, serves as an essential prerequisite for pursuing a Doctorate studies, Ph.D degree, focusing on Niche areas, emerging accounting fields.

Master of Arts | M.A.

1. History

M.A. The History Programme aims to develop an understanding of events, personalities, ideologies, and trends in history and train the students in historical research. It is a two-year full-time programme spread over four semesters. The programme opens the world of regional, national, and international history. A student completing M.A. can take up M.Phil. and Ph.D.

2.Philosophy | M.A. Philosophy

MA Philosophy is a 2-year postgraduate programme divided over the four semesters. It is a majorly theoretical programme which imparts to students the knowledge of different philosophies around the world. A deep and critical study, this helps students to analyze the world better. The programme curriculum ranges from Indian philosophers to the Greek philosophers and also encompasses the western philosophers.

Philosophy, being a rational inquiry, sharpens our thinking, enriches our understanding and expands our intellectual horizons. To acquaint students with such a philosophical understanding the department of Philosophy offers programs of teaching and research in philosophy at M.A. level.

3. Psychology | M.A. Psychology

The Master of Arts (MA) in Psychology is 100 credits 2- years course. In the first year, the course is 24 credits per semester. There are four theory courses and one practical/field work.

In the second year, semester III includes five course work (four credits each) and one practical (10 credits) with a total of 30 credits. 5. Sociology | M.A. Sociology

The Master of Arts (M.A.) in Sociology is a 100 credits two-years full-time course. In the first year, the core course is 24 credits per semester. In the second year, semester III includes five elective courses and one project with a total of 30 credits.

Semester IV has one interdisciplinary course, one ability enhancement course and one project. The project-based course will be in the form of a dissertation based on a live project or a research assignment related to the discipline. The programme incorporates theoretical knowledge as well as field work components.

6. English | M.A. English

RESEARCH POLICY DOCUMENT

1. INTRODUCTION

Research is a prime area of the academic development and without research the knowledge will remain stagnant. The students and researcher scholars are required to have ethical and moral values in academic pursuits in order to produce a genuine research In the present ICT era, information is easily available online and can be used as source material. In this context, plagiarism has become a serious problem. As per the Rules to consider the Proposals for Award of M.Phil. / Ph.D. Degree In Consonance with University Grants Commission Regulations, 2016 (Minimum Standard and Procedure for Award of M.Phil./Ph.D Degree) notified vide its Notification dated 5th May, 2016 and the UGC Notification on University Grants Commission (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018 will remain statutory rules, the Plagiarism Policy of K J Somaiya College of Arts and Commerce, Mumbai (Autonomous) has been formulated with a view to ensure that the institute ensures zero-tolerance for plagiarism in the research work either carried by the faculty, researchers or students.

The UGC has issued guidelines on the above subject vide its gazette notification, of 23rd July 2018, to ensure that the academic and research work done, leading to the partial fulfilment for the award of degrees at Undergraduate, Masters and Research level, by a student, faculty or a researcher, in the form of thesis, dissertation and publication of research papers, chapters in books, full-fledged books and/or any other similar work, showcases academic integrity and originality. The guidelines presented here highlight the steps that are essential to enforce Academic Integrity in the research work that is carried out at K J Somaiya College of Arts and Commerce, Vidyavihar (Autonomous), Mumbai.

1. APPLICATION AND COMMENCEMENT

The policy shall apply to all students, faculty, researchers and staff of K J Somaiya College of Arts and Commerce, Vidyavihar

(Autonomous), Mumbai. These regulations shall come into force with effect from the date of notification on the official College website.

1. OBJECTIVES

This research policy provides a broad framework to guide scholarly research with the following objectives:

- 1. To create and promote a culture of research among the faculty and staff of K J Somaiya College of Arts and Commerce, Vidyavihar (Autonomous) Mumbai.
- 2. To identify research areas and specify research topics of academic, practical and socially relevant significance
- 3. To organize seminars/conferences/workshops on research topics and training programmes in research methodology.
- 4. To ensure quality, integrity and ethics in research.
- 5. To publish research material in appropriate media and to make available such published information to the end users.
- 6. To facilitate the publication of reports submitted by the research scholars
- 7. To bring about an annual/periodic compendium of abstracts/papers presented by the staff and students in various seminars / conferences / workshops.
- 8. To serve as a facilitator providing professional guidance, technical support and recommendation for financial assistance.
- 9. To protect Intellectual Property (IP) generated as a result of research conducted at KJSAC.
- 10. To integrate research activities undertaken and create a rational, transparent and efficient system for management of all research processes

1. PROMOTION OF RESEARCH

The K J Somaiya College of Arts and Commerce, Vidyavihar Mumbai believes that researchers are free to choose the subject of their research, to seek support from any funding source for their research work, and to report their findings and conclusions.

However, research shall be available for scrutiny to the college and constructive criticism of peers. Research techniques used by the researchers shall not violate established professional ethics, pertaining to the health, safety, privacy, and other personal rights of human beings or to the infliction of injury or pain on animals.

The College shall create conducive environment for research. Due to limited resources, the college may not support fully all research likely to be undertaken, but it shall allocate the space, facilities, partial funding, and other resources for research programmes based on the scholarly and educational merits of the proposed research. It shall also provide development opportunities to researchers for writing research proposals and reports, publications, patent filing, etc.

1. RESEARCH AT UNDERGRADUATE AND POSTGRADUATE LEVEL

K J Somaiya College of Arts and Commerce treats teaching and learning should always be amalgamated at each level. Thus, equal opportunities at the graduate and post-graduate level are given and help to promote creativity among the undergraduate and postgraduate students, some research component in the curricula, especially in the final or pre-final year of the bachelors programme and final year in the master's programme is implemented. Accordingly, in the final year of the bachelors programme the Minor Research Project and Major Research Project are inducted where the students under the guidance of the faculty work on the decided topic of the dissertation and submit the findings periodically. The final project is submitted to the institution and also the viva is conducted. Similarly, in the postgraduate programme, research was emphasised emphatically and students were trained for robust research skills. The college shall further reinforce research training in both undergraduate and postgraduate programmes in the future.

1. DOCTORAL RESEARCH

The steps towards the expansion of doctoral programmes are commenced both for full-time scholars and external scholars. Though, college is having limited finance and resources for conducting research and also in the development of the rich infrastructure for conducting research in different fields; therefore, it was decided to allow the research scholars and teachers to collaborate with different prominent National institutions where they have requisite research infrastructures and also have expertise to guide the scholars in different areas. The college shall further boost doctoral research and earmark

appropriate budget for scholarship and research facilities in different institutions. It shall also recognise the worthy R&D organisations for doctoral research and build bridges with them. The college shall continue to encourage faculty and research scholars to get funding for attending International conferences from external agencies as a matching share so that the quality in research paper can be maintained. It shall urge research scholars to publish and patent/obtain copyrights their research work.

1. MINOR RESEARCH PROJECTS

From the very beginning, the college has encouraged young faculty to conduct research. Thus, it has developed a mechanism to guide and facilitate the financial assistance to Minor Research Project. Minor Research Project will be verified and periodical assessment of the research will be conducted by the Research, Review and Recommendations Committee. The committee will help young faculty think about research, prepare the proposal, conduct research and write a research report. It also assists them in preparing proposals for major research projects. The college shall continue to encourage young faculty to take up minor research projects.

1. MAJOR RESEARCH PROJECTS

The college will identify a list of funding agencies. Faculty can submit Major Research Project proposals to these agencies. These proposals are scrutinised before submitting the same to a funding agency by Research, Review and Recommendations Committee. The college will try to provide all kinds of infrastructure facilities available for conducting a Major Research Project. The college plans to evolve a mechanism through which it shall monitor the progress of Major Research Projects funded by an external agency, maintain its accounts and submit the utilising certificate in time to the funding agency as per the requirement of the funding agency.

1. COLLABORATIVE RESEARCH PROJECTS

The Academic-Industry Interaction is the demand of the day. If we want to contribute to the society at large, the college has to closely work with industries and different organisations. The college has planned to encourage industry Sponsored Research Project, Interdisciplinary Research, Collaborative International Research, Training for Research and Publications, Publication of Papers and Journals and helping the researchers in copyrights

/Patent and IPR.

1. INCENTIVES FOR OUTSTANDING RESEARCH

The college would like to encourage quality research in different thrust areas. For this purpose, outstanding research contributions done by faculty, researcher, and research scholar shall be recognised. The institution has various subject associations and cells through which students and faculty members are encouraged to undertake innovative activities which are helpful for creation and transfer of knowledge. Activities conducted by these associations and cells are helpful to develop leadership qualities, various skills, planning, budgeting, marketing and organizing. Activities conducted by language associations are helpful to enhance the skills of languages and creative thinking.

The college has an Entrepreneurship Development Cell (EDC) to promote an entrepreneurial mindset. Throughout the year workshops, seminars and guest lectures on Entrepreneurship are organized by EDC. Students are provided opportunities to directly interact with outstanding entrepreneurs excelling in their field. Expert lectures by industry personals are arranged for students. Individual departments also interact with industry to ascertain its needs to fill the gap in curriculum. Industrial, field and site visits are arranged for students regularly. Faculty members regularly interact with the industry to understand functional challenges through applied research or student projects

College has recognized Research Centres in the Departments of Commerce, Hindi and Gujarati.

Various departments of the college work to together inculcate the spirit and culture of research amongst faculty and students. This in turn helps to enhance interaction and cooperation between researchers for interdisciplinary and multidisciplinary work. 4.1.1 - The Institution has adequate infrastructure and physical facilities for teaching-learning, viz., classrooms, laboratories, computing equipments, etc.

Institution has augmented adequate physical as well as technical amenities to facilitate a smooth teaching-learning process. Institution has managed to maintain a balance in physical and technical infrastructure. All the classrooms and the conference room were equipped with LCD, Speakers and Wi-Fi/LAN facility. One classroom is converted into a smart room with the use of smart board. There are 4 AV rooms with 1 amplifier, speaker and cordless mic. Institution has a well-equipped and well-maintained computer lab comprising 51 computers and a language lab comprising 10 computers with highly advanced audio-video communication software. College has a research lab for facilitating research. There is a Psychology Lab for Psychological experiments. Every teaching faculty has been provided with a laptop and Wi-Fi connectivity in college premises to aid in smooth conduct of online lectures which largely proved beneficial during the pandemic. Institution has provided photocopy, scan and print facility for staff as well as students in the library and in the college foyer.

Institution has an impeccable Auditorium named 'Kalidas Sabhagruh' comprising 6 speakers 2 base 2 stage speakers, 4 hanging mic 1 podium and 2 cordless mic, 1 amplifier, 1 mixer, LCD, Wi-Fi connectivity with a seating capacity of 300. The auditorium is self-reliant with its own full-fledged music system required for conducting programmes. It has 2 green rooms backstage required by performers and organisers for their arrangements before any performance. The Institution has also facilitated a RAM for the disabled so that they can smoothly make up to the stage.

The Institution also has a well-equipped gymnasium for indoor games and physical fitness, consisting of Table Tennis, Carrom, Chess facility, with Football and Cricket kits for outdoor games and Treadmills and Dumbells for workouts. Apart from the college gymnasium, students of the institution can have access to all the sports facilities offered by the Somaiya Vidyavihar management across the campus viz., football ground, basketball court, cricket ground, cricket nets, Kabbadi, Kho-kho ground, Tennis court, Athletic track, Badminton court, Outdoor chess, Squash court, Volleyball court, multi-purpose surface, Kalaripayattu, Taekwondo, Table Tennis court and Gymnasium.

4.2 - Library as a Learning Resource

4.2.1 - Library is automated using Integrated Library Management System (ILMS)

K. J. Somaiya College of Arts and Commerce Library is the oldest and biggest library in the Vidyavihar campus. The total area of it is 10732-sq. ft. comprising of 418 chairs with 80 tables for studying. College library projects a splendid collection of 87000+ books, 758 e-books, 124 periodicals, 2 e-resources, 825 back volumes, 427 rare collections, 8 braille collections, 18 Theses, 1684 CDs, 31 audio cassettes, 59 video tapes, 136 maps and 18 newspapers. The book collection covers most of the areas of knowledge. Though the emphasis is on Indian publications there is a good collection of foreign publications too.

The approximate yearly budget varies from Rs. 6,00,000 to Rs. 7,00,000 including periodicals and journals. Nearly 2000 to 2500 books are added every year. Yearly 50 periodicals are subscribed, out of which four are foreign publications. Many journals are bound after completion of the volume. Past question papers and syllabi are available for reference. Library helps to get photocopies of syllabi to the students going for further studies in foreign countries. Library also maintains a special collection on Career Guidance, Gandhian Literature, material for competitive examinations and CA studies, and a collection of Biographies. It also has some rare books, which are not available in the market and now beyond copyright laws.

There are 4 counters in the library for current reading, home issue, staff issue and reference counter. Library is divided into 8 sections, viz., Acquisition, Periodical, Reference, Current Reading, Home issue, Staff and PG issue, Internet and Computers section and Book-bank. Library is offering free internet, photocopy and print facility to staff and students.

The Institution has a fully automated and user-friendly Library for the benefit of staff and students. The Somaiya Trust has proposed an in-House software programme 'BOOK WARM', which will help to link all libraries in the campus. It has a complete catalogue on computers and Bar-coding has been done. Besides this circulation and statistical records are also maintained on computers. The program has provision for making and printing lists of books for various purposes.

Students can renew books themselves through online (KIOSK), provided the book is not

in demand/reserved. Students can reserve the books through Web OPAC which are not available in the library (issued to other members). System will notify the students through email, to return the book on or before the due date and once the reserved book is back into the library, the system will send notification through an email to the students who reserve the book.

4.4.2 - There are established systems and procedures for maintaining and utilizing physical, academic and support facilities – classrooms, laboratory, library, sports complex, computers, etc.

Institution has a built-in mechanism well communicated through policy manuals for maintaining and utilizing physical, academic, support facilities, viz., for computer lab, library, sports, etc.

Library - Staff and students can login into My Account on Somaiya Vidyavihar Home Page on Library portal through the integrated ID SVV Net ID and Password which is already sent on their mobile and also on their email. Students can renew books themselves online, provided the book is not in demand/reserved before the due date. Undergraduate students can renew the book only once while postgraduate students can renew it twice. Any Member can borrow any one book for seven days from any library of Somaiya Campus. At the Current Reading Counter the textbooks, general books, question papers are provided for current reading only, against the Identity Card. It is necessary to take the Librarian's permission for borrowing books overnight. If the book is not returned in time the student is fined Rs. 2/- per day. Books and periodicals are issued to staff members of the college. Generally books, other than textbooks, are issued for one month and periodicals for seven days. The staff members can borrow not more than 20 books and not more than 2 periodicals at a time. P. G. students are issued two books at a time for home lending for 7 days and three books at a time to read within the library. Reference books marked "R" before class number and Rare Old books are not issued for home reading. All Newspapers are made available for Students & Staff members in the Reference Section. Silence must be maintained in the reading room and any kind of discussion is not permitted in the reading area. Students are not allowed to eat in the library. Guidelines for the use of the Library are informed to staff and students.

Sports - Sports facilities in the institution as well as across the campus are available for use to staff and students provided they produce their appropriate Somaiya ID Cards / Sports Facilities User Cards issued by the Somaiya Sports Academy. Written guidelines regarding rules and regulations to use sports facilities are available and duly informed. Necessary online bookings are essential to use Somaiya sports facilities. Access to all the sports facilities is free of cost for all current students. The student/ player must be in appropriate sports attire i.e. sports specific shoes, t-shirt, Shorts/ track pants. Users will be responsible for any damage to the property in the sports facilities, such as lockers, windows, flooring, furniture, etc. Photo taking with/without flash and video filming are NOT

allowed inside the sports facilities, except if an exclusive permission is taken from the Security and Sports academy. Food, beverages, pets are strictly not permitted into the sports facilities. Smoking and gambling of any sort is strictly prohibited in and around sports facilities.

Laboratory - Computer and Language lab can be used by staff and students subject to furnishing of Somaiya ID card. Lab facilities can be used only in the presence of Lab-in-charge or Lab assistant.

Research Centre - Institute ensures zero-tolerance for plagiarism in the research work either carried by the faculty, researchers or students. The policy shall apply to all students, faculty, researchers and staff of the institute. The research policy provides broad framework to guide scholarly research with the objectives like create and promote research culture, identify academically, practically and socially relevant research areas, organise programmes in research methodology, facilitate publication of research material, provide professional guidance, technical support, recommendation for financial assistance, ensure quality, integrity and ethics in research, protect Intellectual Property Right of research conducted by researchers.

6.5.1 - Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing quality assurance strategies and processes visible in terms of incremental improvements made during the preceding year with regard to quality (in case of the First Cycle): Incremental improvements made during the preceding year with regard to quality and post-accreditation quality initiatives (Second and subsequent cycles)

Curriculum Development:

Curriculum development is taken care of by individual departments as per specific requirements. Syllabus is reviewed and revised as per the suggestions and recommendations given by the expert members of the Subject Board. It is comprises of University Nominee, Subject Experts, Industry Expert, Faculties of Department and Alumni.

Teaching and Learning:

Teachers use Traditional as well as Modern methods to inculcate practical aspects of the subject and to make the students understand the different concepts. Teachers use Traditional Methods like Black Board, Group Discussions, Assignments and Projects, whereas modern methods include PPT Presentations, Google Classrooms, Smart boards, Role Plays, Management games, Visit to Industries etc. Remedial Classes are organized for students of first year, second year, third year Arts and Commerce students to help them prepare for the semester end examinations. Though the medium of instruction is English, teachers are requested to explain points in Marathi and or in Hindi to help vernacular medium students understand important concepts.

Examination and Evaluation:

The academic year 2016-17 saw a change in the examination pattern. The internal evaluation for all subjects is done according to the nature and scope of the subject as follows:

Internal Examination Pattern:

- 1 Management Related Subject -Management Games, Power point Presentations.
- 2 Accounts and costing -Written Examination or Project
- 3 Foundation Course -Project on Social Issues
- 4 Security Analysis Portfolio Management-Comparison of two companies of market on the basis of Technical and fundamental analysis
- 5 Mutual Fund Management Study of Fact Sheet on different mutual funds and Viva
- 6 Research Methodology Project on different topics and viva conducted by external industry experts.
- 7 Banking laws and corporate Laws, Role Play and Moot Court

Online Examination (Using Smart Phones or Android phones) is conducted through OFFEE Software developed by the alumni of the Somaiya college. 20 Marks are allotted to Internal Examination and 5 marks for attendance and overall conduct of the students.

Research:

Research has been considered as an important integral part of the academic endeavours in our college. Many Seminars and workshops are organized by the college to provide expert information on Research Methodology. The college promotes faculty participation in research by granting them leave, helping them in participation of Faculty Improvement programmes and arranging books required by them. All teachers are encouraged to participate and present research papers in International, National State Level Conferences. They are encouraged to take Major and Minor Research Projects. The Management of the Institute has a policy of felicitating the faculty members acquiring Ph.D. Degree at annual prize distribution ceremony. Students are continuously encouraged to undertake Research Projects related to their curriculum.

Library, ICT and Physical Infrastructure / Instrumentation:

The prime objective of Library as a learning resource is to acquire, develop, maintain and provide a qualitative and

quantitative collection of books, periodicals and other instructional material of electronic resources to support the academic program and educational goals of the college. All the modern ICT facilities are available in the college such as Language Lab and Research lab.

Human Resource Management:

The college has adopted mandatory Self-Appraisal Method to evaluate the performance of faculty in teaching, research and extension programmes. At the end of the academic year, every teacher is given an Academic Performance Indicator (API) form on the basis of UGC requirements. Teachers are required to give self-evaluation of academic, co-curricular and extracurricular work done during that academic year. The data of the papers presented at conferences, seminars, refreshers courses and orientation programmes attended is also maintained regularly.

Industry Interaction / Collaboration:

Experts are invited from various fields to deliver guest lectures and industrial visits are arranged. The career guidance and placement cell organize education visits to Reserve Bank of India, BSE/NSC Market, and SEBI. Career fares are frequently organized for placement of the students.

Admission of Students:

All the admissions are strictly as per the rules and regulations of university. Students seeking admissions are required to fill in the admission form of university as well as on college portals. Admissions are given strictly on Merit basis.

Best practice: 1 1.

- 1. Title of the practice Gyan Yagna 2.
- 2. The context that required the initiation of the practice: Our founder Padma Bhushan Shri. Karamshi Jethabhai Somaiya, was pained to see the indifference of youth towards Sanskrit, sanskriti and samskara. Our scriptures are cradle of Indian culture and heritage, treasure of spirituality and great traditions. Young students should not only be made aware of our great scripture but also love and respect our Indian culture. With this motive, Padma Bhushan Shri. Karamshi Jethabhai Somaiya started Gyan Yagna Spiritual sessions in the Somaiya Vidyavihar campus in 1989 and since then we have been following the tradition by organsing these sessions every year in the month of January.
- 3. Objectives of the practice: The prime objective for organising Gyan yagna is to provide spiritual and Para medical services to the society. We involve students in organising these events whereby giving platform for students to do social work and also to learn event management. Cultural programmes are also organised to develop interest in different arts among students.
- 4. The Practice: Every year great Saints and Sages are invited to

speak on Sanskrit texts Veda, Upanishads Purana and Bhagvadgita etc. The Founder of Manana Ashram, Param pujya Shri Tejomayanand, his disciple Swamini Tanmayananda, Swami Chinmayananda, Parama pujya Shri Haribhai Kothari, Swami Avadhutanada maharaj, and many more have been the prominent speakers. As the programme became more popular, gradually two hours in the evening were kept for Cultural programmes like Folk music, folk dance and drama. Further, we had introduced two sessions in the morning where second session was allocated for health. In this session renowned Doctors were invited to speak on health issues and their solutions. Yoga practices were organised. In the year 2021, due to pandemic all events were organised virtually using Zoom platform. Every day Gyan Yagna started with 1st morning session of Pravachan for 7:00 to 8:00 a.m. After providing food for mental health programme was followed by Yoga / Speech / medical camp. In the evening between 6:30 to 8:30 cultural programs were organised.

- 5. Obstacles faced if any and strategies adopted to overcome them : In 2021, pandemic hindered the physical organisation of this event. Considering the viability of the situation, this event was organised online. Although our college is well equipped with IT team, we could not help the attendees to resolve technical issues faced at their end. Every year this programme was organised from morning to evening for one month. But this year it was not feasible to have this program for the whole day so we had it in different slots every day. Most of the speakers were not technology savvy so we faced problem in the conduct of their sessions. As this program is open for all, we generally face issue of security.
- 6. Impact of the practice: In COVID pandemic, when we are surrounded by negative news everywhere, which increased our worries for the social and economic wellbeing of our society, there was a need to spread positivity to overcome all the fear. This event Gyanyagya has been able to create positivity amongst the participants. There arises a need to uplift the physical and mental health of everyone. Gyanyagya through its daily sessions, made an attempt to connect the participants with Indian culture.
- 7. Resources required: There are extensive resources like infrastructure, staff and student volunteers, required to pull out this event on a huge scale for a duration of one month.

 Management has always been keen to support this event in every possible way. In last 32 years, Gyanyagya have never stopped for the dearth of resources.

Best practice: 2

- 1. Title of the Practice: Drushti Film Forum
- 2. The context that required the initiation of the practice: Established in 2007, Drushti Film Forum is a Film Society of the Somaiya Vidyavihar campus, initiated by K.J. Somaiya College of Arts and Commerce. Revised in 2013, so far, it has screened more than 250 films across the countries and themes. (A Film Society is a membership club where people can watch films which would otherwise not be shown in mainstream cinemas.) Drushti Film Forum was established in the academic year 2007-2008 and was inaugurated on 8th August 2007, at the hands of senior actress Suhasinee Muley.
- 3. Objectives of the practice: Drushti Film Forum, with regular weekly Screenings of World Cinema, serves as an effective tool to introduce the Art and Aesthetics of cinema to students. It aims to develop a larger world view in them as this art form introduces them to the realities in the world as well as the advance techniques of medium.
- 4. The Practice : Film is a modern Art form and can be effectively used to educate young minds. In western and European countries, Film is a part of regular curriculum in schools whereas at college and University levels, they have Film Studies departments for much specialized courses in Cinema. For Drushti Film Forum, Film is not merely an entertaining medium but a window to the world. Hence, we preferably screen films from all over the world, from different genres and unconventional subject content. It's their exposure to the World Cinema. Drushti Film Forum used to screen and discuss World Cinema in the college auditorium regularly on weekly basis except examinations and vacation period. Due to pandemic situation, we, for a time being, moved on to online screenings. YouTube link of movies is shared with students on every Friday and they are asked watch it by Sunday, while the film is discussed on every Monday. Along with screenings, we initiate academic discussions on cinema, provide them reference material, conduct film appreciation workshops, encourage them to be part of International Film Festivals.
- 5. Obstacles faced if any and strategies adopted to overcome them

- : Despite our sincere efforts, hardly 100 students regularly attend the screening. And very few students attend the online discussion. However the number of students participating is increasing every year, and efforts are being made to screen movies on topics that interest students.
- 6. Impact of the practice: So far, our four students, Raunak Raje (2010-11), Karan Jhala(2013-2014), Salim Shaikh (2014-2015), Saba Purkar (2015-2016), Omkar Kulkarni and Payal shah (2016-17) have been selected as Young Critics at MAMI International Film Festival in Mumbai.
- 7. Resources required: A cabin space for dedicated work and meetings, Availability of Auditorium, Projector, Screen, Library budget for film related Books and a dedicated Library of Films for screenings and Studies.
