Ms. Karishma Chandwani said that she applied for admission to Ismail Yousuf college. The said college asked her to get the Transfer Certificate from us.

Ms. Chandwani said that she had filed the complaint to University of Mumbai on 11/12/2020.

She stated in the meeting that she received the transfer certificate on 16/12/2020. She also stated that she has withdrawn her complaint to University of Mumbai via email on 16/12/2020 itself.





Ms. Chandwani also stated that she can share with us the mail which she has written to University of Mumbai stating that she is withdrawing her complaint.

Principal Smt. Veena Sanekar stated that college has given co-operation to the students seeking admission outside and also stated that the college informed the said colleges where students had sought admission that the procedure of issuing Transfer certificate was going on.

Principal Smt. Veena Sanekar also stated that they are in receipt of mails from students stating that they were able to secure admission in outside colleges.
